Call for Nominations

The 2025 Annual General Meeting of the Canadian Association of Naturopathic Doctors (CAND) will be held <u>virtually</u> on Saturday, June 14, 2025, at 11:00 am (EDT). A registration link will follow in the coming weeks.

Members attending the CAND AGM will be entered into a draw for an iPad (you must be present to win). Per 7.15 & 7.16 members are reminded of their right to vote by proxy. Please consult the <u>CAND by-laws</u> for further information.

Call for Nominations

The Nominations Committee is seeking nominations per their duties under section 4.03 of the CAND bylaws.

- The Nominations Committee shall recommend candidates for election to vacant positions on the Board of Directors.
- Associations may nominate one representative and said nomination shall be automatically included in the report of the Nominations Committee.

At the June 14, 2025 AGM Dr. Jatish Kaler ND (Alberta), and Dr. Mitchell Zeifman ND (non-clinical) (Ontario), will have completed the maximum term permitted by the CAND bylaws (9 years). Dr. Tara Lantz ND (Nova Scotia) will have completed her second term and having served 6 years is not standing for re-election.

As such the Board is seeking qualified candidates to fill vacancies ensuring the Board has a minimum of 9 and a maximum of 13 persons (Bylaw section 4.01).

Dr. Valerie Penton ND (Newfoundland) and Dr. Renée Purdy ND (New Brunswick) are completing their first and second terms respectively and will be standing for re-election. Dr. Robyn Stanely ND (British Columbia) is up for re-election for the last year of her third term.
